1. **Call Meeting to Order:** 12:10 pm by Steve Eivins, Chair.
2. **Meeting Minutes:** Rick McMorran moved, Ken Manzo seconded to approve the June 14, 2011 meeting minutes as amended; passed unanimously.
3. **Commissioner / Citizen Comments:** No comments.
4. **Events / Updates**
 - A. **HHWF Updates:** Summer participation has been slightly higher than last year. Paint figures are lower due to give-aways to the County Fair, graffiti abatement, and the Rainbow Falls project. Paint consolidation has resulted in disposal cost savings. Western Scrap Processing, a new vendor, is now paying for lead-acid and non-auto batteries plus scrap metal. Phil Chase will provide information on toner recycling. The Black Forest Slash/Mulch Program ends this month; statistics are not yet available. The Treecycle Program kickoff meeting is scheduled for September 29.
 - B. **CESQG Program:** The Conditionally Exempt Small Quantity Generator (CESQG) Program has been well-received; 45 businesses have registered, and over \$1,000 in fees have been collected.
 - C. **2012 Tipping Fee Reporting Form:** The new form was reviewed and the rates of \$0.30/vehicle, \$0.37/cubic yard, and \$1.25/ton were tentatively agreed upon.
 - E. **New Business:** The December meeting will tentatively be held at Phantom Canyon. Treecycle meeting is September 29, 2011.
