2. Interim Drainage Fees are based upon draft Drainage Basin Planning Studies or the Drainage Basin Identification and Fee Estimation Report. (Best available information suitable for setting a fee.)
3. This is an interim fee and will be adjusted when a DBPS is completed. In addition to the Drainage Fee of \$15,000 a surety in the amount of \$7,000 per impervious acre shall be provided to secure payment of additional fees in the event that the DBPS results in a fee greater than \$15,000. Fees paid in excess of the future revised fee will be reimbursed. See Resolution 06-325, September 14, 2006.
